

IMPORTANT- If you do NOT have the three-part NCR carbonless Writ of Execution, print and fill-out one (1) original (legal-front & back) for the court, and then make two (2) copies same for yourself and the recipient of service.

Instructions for Filling Out the Writ of Execution (**for your information ONLY!**)

1. Date – fill in the date. Date should be the same day you mailed it.
2. Name- Print first, middle and last name of the responsible corporate officer.
3. SS#- If you don't have the SS#, contact private investigator for that information. Charge: \$25 per person.
4. Birth date – If you don't have the birth date, you may contact the private investigator to get you that information. Also, if they are an elected official, you may find that public information online.
5. Address- Use the 'workplace' address and the ZIP CODE of the responsible corporate officer's office.
6. EWG.org/tapwater- Use the ZIP CODE to locate the evidence of unlawful discharge. Print and attach to Writ.
NOTE: If you think you can't find the exact water purveyor, just select the biggest purveyor in the area.

Instructions for Additional Counts

7. **VACCINE**- If the responsible corporate officer is involved in promoting the vaccine, you will want to insert at least "1" Count of violation.
8. **5G**- If the responsible corporate officer is involved in promoting 5G, you will want to insert at least "1" Count of violation.
9. **GMO**- If the responsible corporate officer is involved in promoting GMO (genetically modified organisms), you will want to insert at least "1" Count of violation.

Pre-Filled-in Counts (**do not change the Pre-Filled-in Counts**)

You will notice there are three (3) Counts that have already been filled-in creating a total of "6" Counts. These Counts are for their criminal violations occurring at the 'above-defined address' of their workplace, and the Counts of criminal violations occurring at the responsible corporate officer's home.

Serving Citizen's Name and Signature

Serving Citizen/Witness name- The party (you) serving the Writ of Execution on the responsible corporate officer may print and sign name as the second witness of the overt act. To stay private, only send your info to the court.

Lawful Service Procedures

ATTENTION!! Do NOT use "Certified" Mail!!!

You "MUST" serve this Writ of Execution via REGISTERED MAIL!!! RETURN Receipt signed by recipient.

Registered Mail establishes the proper jurisdiction for lawful service of federal actions.

Handwrite in BLUE ink, the REGISTERED MAIL # on **all three copies** just above "UNIFORM WRIT OF EXECUTION."

After you have lawfully served the responsible corporate officer his documents via REGISTERED MAIL, send the original copy of both the Writ of Execution and Registered Mail Receipt to:

Arrest Reward Processing Center care of P.O. Box 1514, Kingsland Texas 78639.

NOTE: You will serve four (4) documents. 1) Cover Letter; 2) Resolution; 3) Writ of Execution; 4) EWG Evidence. The responsible corporate officer will have 30 days to execute the Resolution and return to the court, or a warrantless arrest by any citizen of any citizenship is lawful. The bounty is awarded to the arresting citizen.

The court has authorized a **\$10,000.00 Citizen's Arrest Reward** to be provided to the arresting citizen.

The Citizen's Arrest Reward for arresting a member of the **BAR ASSOCIATION** is **\$20,000.00**, they're special.
