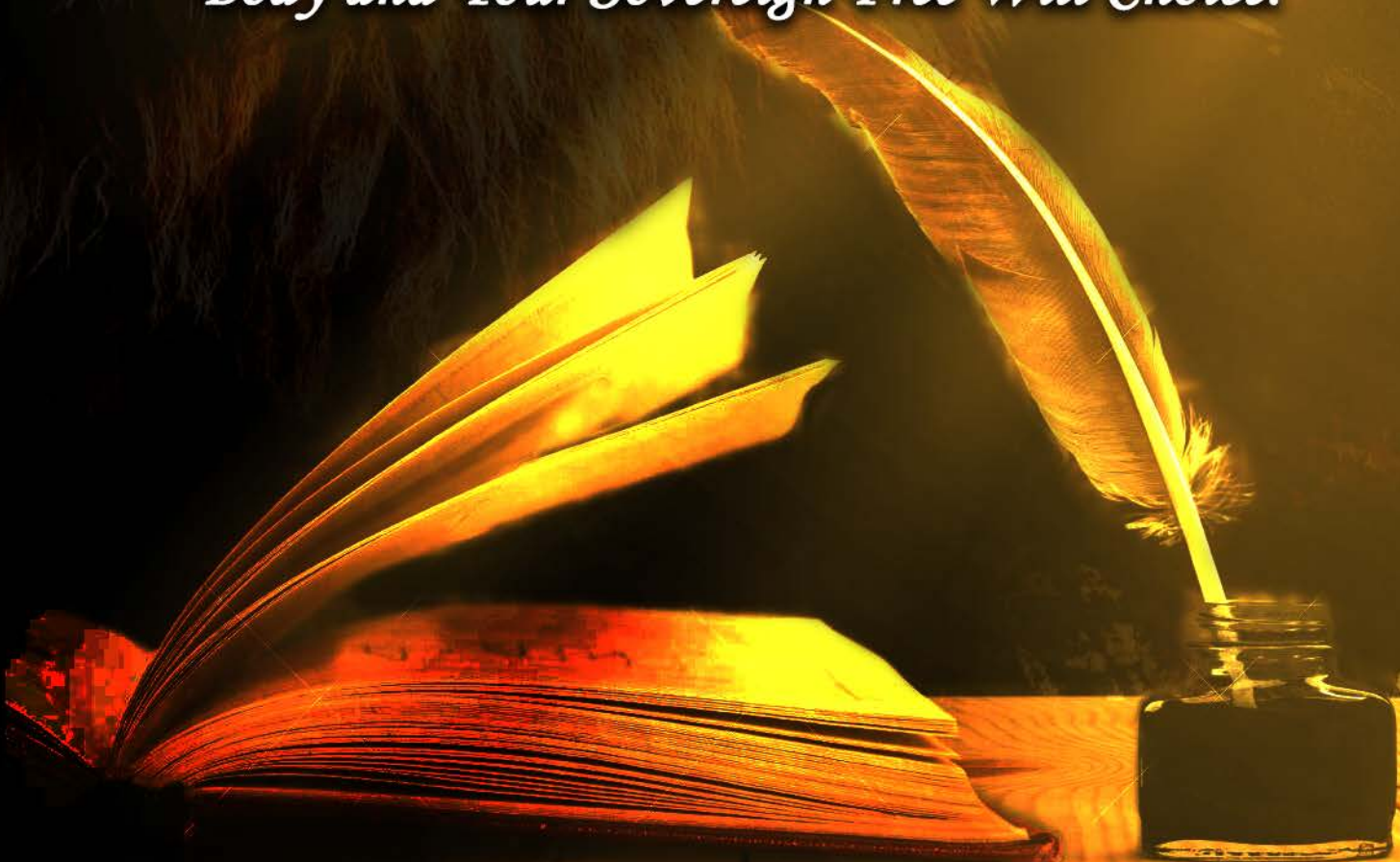

SACRED WRIT OF HABEAS CORPUS

Bring the Body to Our Court of the Ekklesia

Whoever has eyes, let them see! Whoever has ears let them hear!
Let all those present and future be witness to the following:

I, *His Majesty David Joel*, Crown Sovereign of the Kingdom of David, House of Weems, formerly Wemyss, originally the Ancient *House of David*, by My Royal and Sovereign Prerogative, do herewith issue this Sacred *Writ of Habeas Corpus*¹ and do hereby Decree to all to whom this Sacred Writ is presented to be so informed that the Living Men and Women and Children listed below are now held within the enclosure of My Sanctuary under My Protections and Immunities. Those listed below have accepted My Offer of

The Sacred *Writ of Habeas Corpus* shall be reserved for remedy and relief when any Man or Woman is unlawfully detained. It shall also be issued to accompany the Royal Proclamation of Peace and Sovereign Integrity to support the Sovereign Free Will choice of any Man or Woman who accepts the offer of the Proclamation and thereby can utilize the *Writ of Habeas Corpus* to preserve and protect the integrity of his or her body, and those of his or her family.

The Writ shall be served upon the present custodian or officials directly responsible for the unlawful detainment of a Member, ordering that the prisoner be brought before the Court, together with proof of claimed authority as to why the prisoner should continue to be detained.

A Sacred Writ shall be an Order of last resort against clear contempt for the rule of law, any motion for a *Writ of Habeas Corpus* must clearly demonstrate unlawful detainment and a clear injury to the law and must be initiated by a minimum of three sworn or affirmed affidavits of active Members of the Society or individuals directly related by friendship or family ties to the individual unlawfully detained, stating with specificity the nature of the harm and the unlawful nature of the detention.

Sanctuary, Protections, and Immunities pursuant to My Royal *Proclamation of Peace and Sovereign Integrity* (hereinafter “Proclamation”), to which this Sacred Writ is appended and made a part thereof by My reference and inclusion. Each of these have entered into a Contract of High Principle and Sacred Trust and cannot in any way be forced to comply with orders of an inferior jurisdiction against their Will pursuant to their Claim of Right to Life and Sovereign Integrity when such orders presume to have authority over their flesh and blood bodies. Your attention is herewith directed to the accompanying *Individual Mandate of Non-Consent* that cannot be breached for as long as such Living Beings are within the Sanctuary of the *Kingdom of David*.

Said Living Beings have declared by free will choice and moral conscience that they wish to accept My Offer of Sanctuary and be so enclosed within the Sovereign Ecclesiastical Body of the Kingdom, within the Protections and Immunities of *The Ecclesiastical Court for the Kingdom of David* (hereinafter “Kingdom Courts”), and inclusive of the Court of the People as the Living Body of the Christos, the *Court of the Ekklesia*, all of whom have retained the right of removal pursuant to Our Sacred Writs embodied, memorialized, and preserved in the Articles of Establishment for the Kingdom Courts, to wit:

FIRST: LET IT BE KNOWN TO ALL that upon this Nineteenth Day of this Ninth Month in the Common Era Year Two Thousand Twenty One, the Living Flesh, Blood, Bones, and DNA, Kyle Arsenio of the Clan/House/Family of Kordysz (hereinafter "Kyle Arsenio") did accept My Offer of Sanctuary, Protections, and Immunities pursuant to My Proclamation, and thereby did establish a Binding Contract, the obligations of which are preserved and protected as a Sacred Trust within the Kingdom Courts, and did issue his personal absolute Claim of Life and Right by Declaration of Peace and Mandate of Non-Consent (hereinafter “Claim of Life”) that has been entered into the Permanent Archival Records of the *Court of the Ekklesia* (see Court Record Number below); and

SECOND: LET IT BE KNOWN TO ALL, that pursuant to the above referenced absolute Claim of Life that the living Men, Women, and Children listed below are included in the contractual Protections and Immunities of the *Kingdom of David* and are considered as sacred ground that cannot be touched by presumptions of inferior authority. I have established *D'Vida Private Society* and *D'Vida Private Contract Association* with the founding document being My *Proclamation of Peace and Sovereign Integrity*. All Members thereof have accepted My Offer of Sanctuary, Protections and Immunities and have pledged their sacred honor and their eternal word as bond to protect and preserve the integrity and sanctity of each and every Living Being therein, including their Lives, Bodies, and their genetic and ancestral lineal estates, and shall as One, as a body together, known as the Ekklesia, move Heaven and Earth to so protect all Living Beings within the Sanctity of this Society.

THIRD: LET IT BE KNOWN TO ALL, that any public actors, officers, offices, agents, agencies or other parties similarly situated, operating within the limited liability of the United States corporation known as UNITED STATES (inclusive of all orthographic derivatives and variations thereof) or any other NATIONAL CORPORATE entity, and all corporate sub-divisions thereof, who attempt to breach this Sacred Trust or to move in any way to prevent this Lawful Sacred Writ from being honored and obeyed, shall be documented as having breached the public trust and having engaged in the act of willful trespass by their attempt to entice a living being into involuntary servitude and slavery, and to have committed war crimes and crimes against the peace and humanity under the Nuremberg Principles that have been binding on all public actors, officers, agents, offices, and agencies for seven decades, and shall thus be held liable for all such acts with all rights and remedies reserved for the deliberation and settlement of all injury and harm caused thereby within the Law Form and Jurisdiction of the *Kingdom of David* and its Ecclesiastical Court, pursuant to Ecclesiastical and Natural Law and the universal Maxims of Equity.

THIS IS A SACRED WRIT OF THE COURT OF THE EKKLESIA FOR THE ECCLESIASTICAL COURT FOR THE KINGDOM OF DAVID; SEALED INTO AND PART OF THE PERMANENT ARCHIVAL RECORD THEREOF, WITH SPECIFIC NOTICE TO ALL PUBLIC OFFICERS AND AGENTS AND PRIVATE PARTIES

SACRED WRIT OF PROHIBITIO

I, *His Majesty David Joel*, House of Weems, formerly Wemyss, originally the Ancient House of David, by My Royal and Sovereign Prerogative, do herewith issue this Sacred *Writ of Prohibitio*¹, and give Notice to all relevant parties who are hereby noticed and ordered to honor this absolute prohibition against trespass on the Living Flesh of the Men, Women, and Children herein identified below. Said Living Beings are forthwith and forever protected within the *House of David*, a Sanctuary of Peace and Sovereign Integrity,

The Sacred *Writ of Prohibitio* shall be reserved for remedy and relief to order an inferior Court to cease any and all further action on a matter as such have been addressed by a superior Court (*Kingdom of David Court of the Ekklesia*). Whilst similar to the *Writ of Certiorari*, the *Writ of Prohibitio* does not require the inferior Court to provide any records to the superior Court, simply to cease any and all further action in the matter.

Additionally, a *Writ of Prohibitio* shall be issued to any Court or Law Enforcement Officer under orders from an inferior Court to perform such actions or duties under order from said inferior Court, if and as appropriate, to prevent pending, imminent, potential or further injury or harm to any member of the *Kingdom of David D'Vida Private Society* and *D'Vida Private Contract Association* (henceforth "Society" and "PCA" respectively) who has brought his or her action or case into the jurisdiction of the *Court of the Ekklesia* until such time as the Court has an opportunity to schedule hearings or trial for the settlement of the matter and proper adjudication of the case.

The Writ shall be served upon any inferior Court where matters have already been heard and judged by a superior Court, but the matters have not yet been completed in the inferior Court, or when an inferior Court is preparing to pass judgment on such matter and the member brings the case into the jurisdiction of *The Ecclesiastical Court for the Kingdom of David* (henceforth "*Kingdom Courts*") for adjudication and settlement. It shall principally be used as remedy and relief where a member of the Society and Private Contract Association motions the Court to hear and resolve the matter. As has been established by the *Articles of Establishment of The Ecclesiastical Court for the Kingdom of David* the *Kingdom Courts* stand at the highest jurisdiction of all societies both internationally and domestically, and all public officers and agents of domestic bodies and the courts thereof are seen as inferior jurisdictions and are obliged to immediately cease any further action upon issuance and presentment of a *Writ of Prohibitio*.

The Sovereign Integrity of the Living Beings listed below is held within the Sanctuary, Protections, and Immunities of the *Kingdom of David*. The Flesh, Blood, Bones, and Genetic Material (DNA) of the said Living Beings are held sacred and inviolate by My Order and Writ. Such protections are established by an Ecclesiastical Court order, pursuant to the absolute Claim of Life and Right by Declaration of Peace and Mandate of Non-Consent of the Absolute Title Holder named below. Said order is identified by the Permanent Court Record Number entered below and the Court of Record held within the Permanent Archival Records of the *Kingdom of David Court of the Ekklesia*. Each Living Being is seen in My Eyes as a unique living expression as one cell in the Living Body of the Christos, the Ekklesia of those who are set apart and Preserved as sacred within My Protections and Immunities.

All public officers and agents are ordered to comply with their binding codes and statutes, inclusive of all deputies, agents, and representatives under any public office of trust and any public officers thereof, inclusive of any inferior courts, health departments, or other corporate commercial entities. All equitable rights are expressly preserved and any claims are subject to the jurisdiction of *The Ecclesiastical Court for the Kingdom of David*.

MANDATE OF NON-CONSENT

By a Living Being with Claim of Life and Universal Rights
Acceptance of Sanctuary, Protections, and Immunities

TO ALL TO WHOM THIS DECLARATION IS PRESENTED, this is My Claim of Right, Life, and Sovereign Integrity. It is My Expressed Authentic Declaration of *Inter Vivos Trust* (A Sacred Trust Amongst the Living) as a Declaration of Peace and Sovereign Integrity. This is My acceptance of the Offer of Sanctuary, Protections, and Immunities issued by Royal Proclamation and Decree by *His Majesty David Joel*, Crown Sovereign of the *Kingdom of David*. My acceptance constitutes a binding private contract, an Offer and Acceptance that no man or manmade institution can impede or impair the rights and obligations thereof. Said contract has established a Sacred Trust within the Sanctuary, Protections, and Immunities provided by the *House of David*; it is a Contract Inviolable by Divine Writ and so engaged pursuant to My Deeply Held Personal Beliefs and Private Conscience; and

This is My Notice of Intent to enter this Declaration into the Permanent Archival Record of the *Court of the Ekklesia* within *The Ecclesiastical Court for the Kingdom of David*. I hereby inscribe My Unique Signature Frequency and enter into the Book of Life. I do so of My Sovereign Free Will choice to align My Life with all of Life and the Principles of Universal Law and Equity. I Claim My Living Substance and Eternal Soul as uniquely and solely Mine, and I declare that I am at Peace with all of Mankind and all institutions thereof, both public and private, and I am aligned with the Royal *Proclamation of Peace and Sovereign Integrity*.

I herewith hold and preserve the Protections and Immunities provided within the Sanctuary of the *Kingdom of David*. In so doing, the sanctity of My Living Flesh cannot and shall not be violated without My full and absolute written consent, nor that of My children or immediate family members that I have named. This is My Declaration that I do not consent to be subjected to any forced intrusion on My Body, through medical actions such as vaccinations, capture of My genetic material, forced immersion within dangerous electronic frequencies that are deleterious to My well-being and that of My family (who are herewith protected under this declaration and the *Royal Proclamation of Peace and Sovereign Integrity* attached hereto), or by any other means without full disclosure and My written consent.

Any agent, officer, or representative of any public domestic government, international institution or agency thereof, must present written authority whereby they presume to supersede this Order and the attached Royal Proclamation, including the *Writ of Habeas Corpus* and *Writ of Prohibitio* issued therefrom. Such written authority must be autographed with original wet ink autographs by said Agent and His or Her superior, under penalty of perjury and full commercial liability, to be sent by registered mail to My postal location as provided below. If such written authority is presented, I shall readily accept it and honor it to the full extent of the law. But failing to do so, all such public actors and agents shall immediately withdraw their claims and under the mandates of the public trust, each shall be therewith appended to the said Royal Proclamation and be required to maintain the Protections and Immunities as provided thereby.
